# Yuba Sutter Bar Association Meeting Minutes March 19, 2019 The Refuge Restaurant

- 1. Courtney Gengler, President, began the meeting with welcoming remarks and announcements.
  - a. Our next regular meeting will be **Tuesday, April 23, 2019**. Please note the date. Our program will be the Sacramento Valley Chapter of ABOTA (American Board of Trial Advocates) Civility Matters Program. The program has a panel that includes a Superior Court judge, two attorneys and two moderators. Yuba County Superior Court Presiding Judge Givens has agreed to act as our judge on the panel. We will send out a flyer with more information.
  - b. Scholarship applications are now available through the local high schools, Yuba College, and also on our website. Applications are due April 2, 2019.

- c. Bar Association Membership dues for 2019 are \$50.00 and are now due. We discussed at our last meeting increasing membership and meeting attendance. We posted a link in the newsletter to the article entitled, "The Case for Bar Associations: Why They Matter," by Adrienne B. Koch. Read it, share it. Please let us know names and contact information of any local attorneys who should be added to our contact list.
- d. The Yuba County District Attorney's office is recruiting for either a Deputy District Attorney I/II or III. See the flyers included in the email for more information.
- e. Sutter County Notice Regarding Calendar Changes: Effective immediately, the calendar sessions for restraining order requests are being modified, as follows: Courtroom 1 Domestic Violence without children, harassment, elder abuse, and workplace violence requests will be heard on Tuesdays at 1:30 p.m.; Courtroom 2 domestic violence with children requests will be heard on Tuesdays at 3:30 p.m. This schedule change is being made in part to facilitate the use of court-funded court reporters in restraining order matters.
- 2. Elections for the 2019 YSBA Board: The current three board members (Courtney Gengler president, Jessica Hiller treasurer, and Melissa Poulos secretary) are willing to remain in those offices for 2019.

- 3. The MCLE presentation was provided by Donya Thompson, the Deputy Chief of the Juvenile Unit at Sutter County Probation, Sarah Roberts with Sutter County Probation, and Meagan Hammond with Sutter County Probation. The presentation was an overview of Probation's juvenile programs, including services provided and how changes over the past 11 years have resulted in a huge reduction of juveniles in the system. The current case-load is only 40 juveniles, and no juveniles in Camp Singer.
  - The juvenile programs offered by Sutter County Probation include: Cognitive Behavioral Therapy, Seeking Safety, Functional Family Therapy, G.R.E.A.T., Parent Project, and Forward Thinking.
  - The speakers also provided information on their new mentoring program, including that they are in need of mentors, particularly male mentors.
