Yuba Sutter Bar Association Meeting Minutes March 21, 2023 Carmine's at Hillcrest Plaza

1. Courtney Gengler, President, began the meeting with welcoming remarks and announcements.

Announcements:

- a. Scholarship Applications for 2023 are available to local high school seniors with a due date of April 3, 2023. One recipient from each local high school will receive \$1,500.00 and one All-School recipient will be selected to receive \$2,500.00.
- b. Friday, April 21, 2023 at 5:15, we will be having a wine tasting event at Sicilia Vineyards. The cost will be \$15 per person, which will include wine tasting, food pairings, and live music. This event is open to YSBA and guests.
- c. Our next regular meeting will be May 16, 2023. More info to come.
- d. Member Dues for 2023 are now due in the amount of \$75.00. The member dues pay to keep YSBA running: our P.O. Box, our website, our MCLE certification, pay our tax preparer, and they supplement our lunch meetings. Carmine's is working with us, but we still need people to pay their dues.

- A question was asked about the bank account balance. Melissa Poulos, Secretary, gave
 an approximate breakdown, indicating that we had about \$1,000 in the checking
 account, but that we owe \$400 for the website, \$1,200 for the tax preparer, and \$400
 for MCLE provider renewal fees.
- 2. Courtney Gengler introduced the speaker, Tahmina Morrow, Deputy County Counsel for Yuba County. Tahmina presented on the CARE Act and the CARE Court Process. She shared with us that Yuba and Sutter Counties are to implement CARE Court by December 2024. She provided us with a breakdown of the Welfare and Institutions Code sections, including:
 - 5972: Who qualifies
 - 5976: Rights of Respondent
 - 5974: Who can file a Petition
 - 5973: Venue
 - 5975: Contents of Petition (JCC forms and Rules of Court)
 - 5982: Care Plan

Tahmina provided a flow chart, which was distributed before the meeting began, and a PowerPoint presentation, which was forwarded to attendees after the meeting. Tahmina also shared that a case had just been filed on January 26, 2023: Disability Rights California v. Gavin Newsom.

Questions were asked and answered about enforceability of court orders re: meds, hearings, length of program, funding, and housing.

3. Courtney Gengler thanked the speaker and adjourned the meeting.
