This month's presentation is entitled "Community Court" and our speaker is Chris Sachs, the Police Chief for the City of Marysville. Community Court is a homeless diversion program that started in 2018. It was developed to reduce barriers to services, help navigate the court system, and provide an enforcement and accountability tool for the homeless population who are involved in the judicial system.

This presentation qualifies for 0.5 hours of MCLE credit.

Prior to his appointment as Marysville's Police Chief effective March 1, 2018, Chris Sachs was a 17-year veteran of the department, serving as a Patrol Officer, Sergeant, member of the Special Enforcement Team, Division Commander, and Lieutenant. He has received a CHP Lifetime Achievement Award for recovery of stolen vehicles, a Mothers Against Drunk Driving Award for the most DUI arrests in Northern California, the 2017 Marysville Employee of the Year Award, and the Yuba County Probation Department's Victims Service Award for exemplary service with victims of violent crimes.

### Yuba Sutter Bar Association Meeting Minutes, April 23, 2019, The Refuge Restaurant

- 2. This month's MCLE presentation, Civility Matters, was provided by the American Board of Trial Advocates (ABOTA). The presentation was a panel consisting of a Judge, two attorneys and two mediators, who discussed real situations that confront lawyers. Our panelists were:

The judges in attendance were introduced: Presiding Judge Debra Givens, Judge Benjamin Wirtschafter, Judge Kathleen O'Connor, Judge Laura Davis, Judge David Ashby, Judge Sarah Heckman, retired Judge Christopher Chandler, and retired Judge Tom Hill.

The presentation began with a discussion of the Attorney's Oath, particularly the last sentence: "As an officer of the court, I will strive to conduct myself at all times with dignity, courtesy, and integrity."

The panelists were asked questions and shared experiences and opinions regarding what it means to be civil in the practice of law, and the success rate of attorneys demonstrating civility vs. not. Two video clips and an audio clip were also played for the panelists to discuss. Lastly, the judges in attendance were asked to share their experiences.
