This month's presentation is "Cellphone Forensics: Applications in Discovery and Investigations." Cellphones represent one of the fastest-changing areas of legal practice. Mobile device evidence is more important than ever, thanks to the rapid evolution of the technology and the way this evidence is treated by the courts. Touching on important recent cases, technology developments, and Califorensics' direct experience advising attorneys, this presentation provides up-to-date guidance on the application of cellphone forensics in litigation, investigations, and other legal matters.

<u>Yuba Sutter Bar Association</u> <u>Meeting Minutes, September 17, 2019, The Refuge Restaurant</u>

- 1. Courtney Gengler, President, began the meeting with welcoming remarks and announcements.
 - Our next regular meeting will be Tuesday, October 15, 2019. Cory Hamma, Director of Digital Forensics, will be presenting "Cellphone Forensics: Applications in Discovery and Investigations."
 This presentation will qualify for 1 hour of MCLE credit.
- 2. This month's presentation is "What to Do (and Not to Do) in Court," by Sutter County Judge Perry Parker. Judge Parker graduated from Pomona College in 1969 and from Hastings Law School in 1972. He was appointed to the bench in 1990 and he has been the civil, probate, and family law (without children) judge since 1994.

The presentation was divided into three parts: what to do before court, what to do in court, and what to do after court. Some of Judge Parker's suggestions included these topics: do your research, be on time, get the dates for service right, pre-mark your exhibits, submit trial briefs timely, prepare the order timely, inform the court if there is a settlement, keep argument out of declarations, and listen to the answer when you ask a question.

There were a few questions asked and answered at the end.
