Yuba Sutter Bar Association Meeting Minutes June 19, 2018 The Refuge Restaurant

- 1. Courtney Gengler, President, began the meeting with welcoming remarks and announcements.

This is the agency that received one-third of the funding that had been allocated to Yuba Sutter Legal Center for Seniors with a plan that relied almost entirely on pro bono services, and apparently, donations from attorneys in Yuba and Sutter Counties.

Beginning July 1, 2017, Electronic Filing became mandatory for attorneys filing papers in Civil cases, Probate cases and Family Law cases. Beginning March 1, 2018, Electronic Filing became available (not mandatory) in criminal cases.
