This month, we will have a panel of speakers from different community organizations to discuss the local response to homelessness. This meeting will qualify for 0.5 hours of MCLE.

Our speakers are: Johnny Burke, Executive Director of the Sutter-Yuba Homeless Consortium;

John Floe, retired Program Manager Community Services Sutter County Public Health, Sutter-Yuba Behavioral Health

**Andre Licon**, Sutter County Sheriff Deputy, Homeless Outreach and Engagement Coordinator

Since 2020, Johnny Burke has served as the Executive Director for the Sutter-Yuba Homeless Consortium, which connects the local homeless population with available programs and services. In this role, Burke has helped develop the future of the consortium by coordinating the services of community-based organizations, faith-based organizations and local governments to provide a continuum of services and maximize resources to better serve the homeless people of Sutter and Yuba Counties. He also serves as a pastor at the New Beginnings Wesleyan Church in Marysville, and has worked with many local ministerial organizations to help with the concerns of homelessness in the bicounty area.

Prior to retiring last year, for 17 years, John Floe led a team of professionals at the Sutter-Yuba Behavioral Health Department managing behavioral health, substance abuse, and homeless service programs. He has worked as the Resource Specialist, Prevention Services Coordinator, and Program Manager. The teams have provided Homeless, Health Education and Prevention, and Early Intervention Programs helping those in our community. Those served has found shelter, housing, supportive services, health education, suicide prevention, bullying prevention, life skills, and mental health first aid to name a few. He served on the Sutter-Yuba Homeless Consortium Board of Directors since 2010, providing leadership to the Executive Director, and providing Staff for the homeless programs with partners in two counties. Since 2014, he served as the elected OPUD Board Member. He holds a Master's Degree in Organizational Management. He is a US Air Force Veteran, 23 years, and the Assistant Pastor at Truth Tabernacle Church of Marysville since 1991.

Andre Licon is a member of the Sheriff's Community Response Team that focuses on quality of life issues impacting Sutter County. As the Homeless Outreach and Engagement Coordinator, Deputy Licon has dedicated significant time and energy towards helping some of the most vulnerable members of our local communities. A self-described "Jack of all Trades," he has also worked as a patrol deputy, field training officer, bike patrol coordinator, court security, tactical team member, range instructor, dive team member, and search and rescue team member. In 2021, he was awarded Officer of the Year, with Sutter County Sheriff Barnes stating that, "Andre exemplifies what it means to represent the Sutter County Sheriff's Office, through his hard work and focus on bettering our communities."
