Meeting Minutes  
May 17, 2024, noon – 1:00 p.m.  
Sutter County Superior Court, Jury Assembly Room and Zoom

1. Courtney Gengler called the meeting to order. Zoom sign-in instructions were provided by both YSBA and Butte County Bar Association. This presentation will qualify for one hour of MCLE Ethics.
2. Courtney Gengler introduced the speaker, Sutter County Superior Court Judge John K. Hinely.

Judge Hinely presented on Rule 8.3 of the California Rules of Professional Conduct: Mandated Reporting. The goal of the presentation was to inform the participants of their obligations under the new rule. Hypothetical scenarios were discussed, and questions were asked and answered. Judge Hinely's PowerPoint presentation will be provided to participants by email.

3. Courtney Gengler made announcements for YSBA after the presentation:
  - We are still accepting annual dues for 2024. \$100 per member.
  - We will be taking a break from our regular meetings during the summer months. However, on **June 11, 2024**, we will be co-sponsoring the Alliance for Hispanic Advancement's scholarship banquet at Boyd Hall where Judge Santana will be speaking. We will send out more information soon.
  - Our next regular meeting will be Tuesday, August 20, 2024, at noon.
