Yuba Sutter Bar Association Meeting Minutes August 21, 2024, 12:00-1:00 p.m.

Ag Commissioner Conference Room: 142 Garden Highway, Yuba City, CA 95991

- 1. Courtney Gengler called the meeting to order and made announcements:
 - Our next meeting will be Tuesday, September 17, 2024. Details TBA.
 - We have access to the Attorney Meeting Room in the Yuba County courthouse on the second floor. The door code is #21500.
- Courtney Gengler introduced the speakers: Lizette Perez, a Child Support Attorney with the Colusa Sutter Yolo Regional Child Support Agency (CSY RCSA), and Anne Glanzer, the Lead Attorney with CSY RCSA.
- 3. Lizette and Anne presented on the Flexibility, Efficiency, and Modernization in Child Support Program (FEM) Final Rule Changes Senate Bill 343. They provided background information prompting the changes to the child support program, as well as information about the changes:
 - Child Support Passing Through to those on aid, Family Code section 17504.2
 - Child support formula and calculators, Family Code section 4055
 - Child support add-ons, Family Code section 4062
 - Presumed income and earning capacity
 - i. Default prove-up hearings, Family Code sections 4058(b) and 17430 (Effective 2026)
 - Low Income Adjustments, Family Code section 4055(b)(7)
 - More latitude to deviate from guideline, Family Code section 4057
 - Automatic adjustments for incarcerated payors, Family Code section 4007.5
 - "Uncollectable debt," Family Code section 17400(a)(2)
 - Definition of Annual Gross Income, Family Code section 4058
- 4. Questions were asked and answered. The PowerPoint presentation will be provided to attendees by email after the meeting.
- 5. Courtney Gengler thanked the speakers and adjourned the meeting.
