2. Judge Javellana welcomed and thanked participants, community members, and Jim Tanimoto.
3. Korematsu v. United States: A Reenactment and Community Program

The Program began with a viewing of the Documentary, "Mr. Tanimoto's Journey." Then Mr. Tanimoto spoke and answered audience questions about his time in the internment camp and about his family.

The second part of the program took place in Courtroom 1, with a reenactment by local students of the play, "Korematsu and his Fight for Justice."
